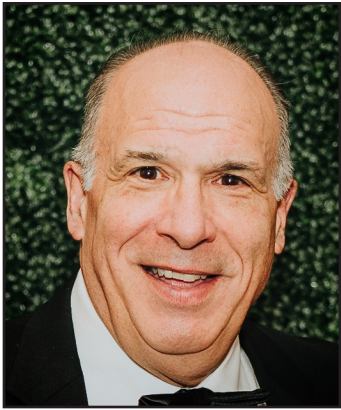


David A. Gallina
